TOURNAMENT RULES

1. All USBC Rules and Regulations Govern the Conduct of the Tournament. This Tournament is USBC sanctioned.
2. Tournament is open only to sanctioned members of the USBC and the NWPAUSBC, **50 years of age and older**.
3. Each event shall consist of three (3) games bowled on one (1) pair of lanes assigned by the Tournament Director.
4. Entering average: USBC RULES 319A-319B-319C-319D-319E apply.
5. Bowlers may enter with a different partner and cash each time. Singles may enter more than once, but cash only once.
6. Bowlers must bowl in the order as they appear on original entry.
7. No bowling will be allowed on tournament lanes one hour (1) prior to the start of any squad.
8. Six (6) minutes of practice play shall be granted prior to each squad.
9. **RULE 327:** Loss of scores: If scores are lost, the game(s) will be bowled over.
10. **RULE 329:** Appeals/protest: Appeals or protests received in writing prior to the payment of prizes will be given consideration. Obvious scoring errors in calculation must be submitted 24 hours after bowling.
11. **USBC ARTICLE 5:** An eligible bowler without a current sanction card may purchase an unattached membership at the time of bowling for \$15 or a one (1) time \$6.00 participation fee. Non-members living within the jurisdiction of the NWPAUSBC, who are not members of another association
12. No more than one (1) professional may compete on a doubles team.
13. **Tournament Handicap: 230 shall be used as scratch basis. Handicaps shall be based on 90% of the difference between entering average and 230 for singles and 460 for doubles. Handicaps will be Computed on a three game series.**

AWARDS

14. The NWPAUSBC will award trophies/plaques to the champions.
15. Prize fees will be returned 100% at the ratio of at least 1 in 8 entries in Doubles and Singles and 1 in 10 entries for all events based on handicap scores.
16. In the case of ties for first place, money will be divided equally. Co-Champions will be declared and duplicate Trophies and plaques will be awarded.
17. All decisions by the tournament manager shall be final unless an appeal is made in accordance with **Rule 329**.

AVERAGE RULES HIGHLIGHTS

RULE: 319A. 1, 2:

- A: Bowlers shall use their highest book average for the 2021-2022 season. at the time of bowling.
- B: If the bowler's highest current average with a minimum of 21 games is 10 pins or more higher, the current 2022-23 average will be used.
- C: Summer league averages will be accepted, if they were submitted to the Association Secretary.
- D: USBC Rule **319B:** If neither average is available, bowler will bowl scratch. If no 2021-2022 OR 2022-23 average, then the bowler will bowl scratch.

RULE 319A.3:

- A: Bowlers are responsible for verifying their own average.
- B: If the submitted average is lower than the required and results in a lower classification or more handicap, the bowlers score is disqualified. If the submitted average is higher than required, prize winnings will be based on the submitted average. In case of a team, the averages will be combined to determine if the correct total is higher or lower than the submitted total.

RULE 319A.4:

Corrections can be made up to the end of a series, or, if an extension of time has been granted in writing by The Tournament Director before the end of the first game of a series, the correction can be made within 48 hours after the end of the series.

RULE 319C:

Re-rating: The average of a bowler may be adjusted upward before participation, in any event.

RULE 3190:

Prior prize winnings exceeding \$600 in the past 12 months in any one event must be declared to the Tournament Director.

RULE 319E:

Tournament average: Participants are to be familiar with the average adjustment requirements.
